3. The bids shall be received till **16-12-2020 at 11:00 am** and will be opened on the same day at **11:30 am** in the presence of interested bidders in the office mentioned below. If the day of submission / opening of bids is declared as holiday the bids will be opened on the next working day.

Bidders are required to submit bid security of amounting to Rs. 80,000/- (1% of Estimated Cost of Rs. 8,000,000/-) in the form of Banker's Cheque / Bank Draft / Call Deposit Receipt in the name of the Project Director, Capacity Building of Occupational Safety & Health (OSH) Regime to Promote Safer Working Conditions at Workplaces.
5. Bidders should give their best & final prices / rates as no negotiation will be held.
6. The **Single Stage Two Envelopes** bidding procedure as per Rule 38(2)(a) of Punjab Procurement Rules, 2014 shall be adopted.
7. The procuring agency may reject all bids any time prior to acceptance of any bid as laid down in Section 35 of the Punjab Procurement Rules 2014.
8. No tender document will be sold on tender opening day.
9. The tender received after the deadline date and time will not be entertained in any case.
10. The interested bidders shall submit their technical & financial bid, inclusive of all applicable government taxes/duties in sealed envelopes, containing name of the firm and marked technical bid & financial bid in the undersigned office.
11. The procuring agency may reject all proposals without assigning any reason prior to acceptance of the bids/proposal as per rule 35 of PPRA rules 2014. The procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds. The procuring agency shall incur no liability, solely by virtue of its invoking sub-rule (1) towards the bidders.
